1. Responsibilities

Identify and refer eligible candidates to the academy for admission and provide complete documentation and verification of the candidate's relation with the Police employee of District Bahawalpur.

2. Validity

This MOU shall be valid for a period of three years from the date of signing and may be renewed upon mutual consent of both Parties.

3. Termination

Either party may terminate this MOU by giving a written giving a written notice of 30 days, with valid reasons, to the other party. However, students already enrolled under the MOU terms shall continue to benefit as agreed until completion of their session.

4. General Terms

This MOU is a statement of mutual intent and does not create any legally binding obligation. Any disputes arising out or in connection with this MOU shall be resolved amicably through mutual discussions.
