Memorandum of Understanding
Between
Punjab Police Government of the Punjab
&
Kips College Hasilpur Campus

Preamble:

This Memorandum of Understanding (MoU) is made on this *Thursday* day of **22 - 10**, 2025, by and between:

District Police Bahawalpur through DPO Bahawalpur, here in after referred to as the “Bahawalpur Police”.

AND

Kips College Hasilpur Campus, having its main campus at Chonawala road Hasilpur, hereinafter referred to as the “College”.

Collectively referred to as the “Parties”.

1. Purpose

The purpose of this MOU is to establish a mutual understanding and agreement between the Bahawalpur Police and the College regarding a special concession of 50% discount on tuition fee for blood relation of the District Bahawalpur Police employees.

2. Scope of the MoU

The College agrees to provide a 50% discount on tuition fee for the academic programs offered to students referred by the DPO office. The discount shall apply only to the tuition fee component and does not include admission fee examination fee hostel fee, or other administrative charges unless otherwise stated.

3. Eligibility

The referred student must be formally recommended by the DPO office through an official letter Student must meet the admission criteria of the

College as per its rules and regulations. The discount applies only for the duration of the program, subject to the students subject to the subject to the student's satisfactory academic performance and adherence to college rules.

4. Responsibilities

Identify and refer eligible candidates to the College for admission
Provide complete documentation and verification of the candidate's relation with the Police employee of District Bahawalpur.

5. Responsibilities of the College

Offer a 50% tuition fee discount to all eligible candidate referred by the DPO Bahawalpur office Ensure transparent admission and fee process for such candidates.

6. Validity

This MOU shall be valid for a period of Five years from the date of signing and may be renewed upon mutual consent of both Parties.

7. Termination

Either party may terminate this MOU by giving a written giving a written notice of 30 days, with valid reasons, to the other party. However, students already enrolled under the MOU terms shall continue to benefit as agreed until completion of their session.

8. General Terms

This MOU is a statement of mutual intent and does not create any legally binding obligation. Any disputes arising out or in connection with this MOU shall be resolved amicably through mutual discussions.

In witness whereof, the parties through their duly authorized representatives, have executed this MOU on the days and dates set out below and certify that they have read, understood and agreed to the terms and conditions as set forth herein

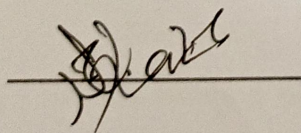

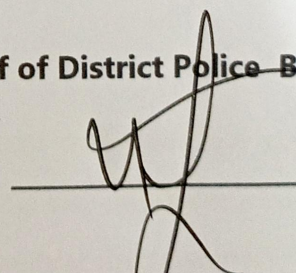
