Cooperation Framework:

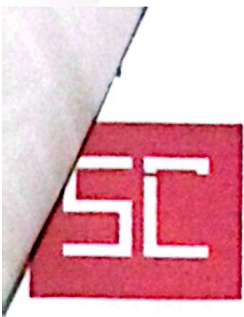

- This MoU does not create any legal obligations or financial liabilities beyond the agreed-upon terms.
- Any amendments or modifications to this MoU shall be made in writing and signed by both parties.

Objectives & Discount Offers:

Syed Lab & Radiology, Bahawalpur while exercising corporate social responsibility will join hands with District Police for the welfare of the personnel of District Police Office in the shape of investigation of diseases through blood sampling and other facilities with following terms of references:

1. On the production of Valid Police Card at the counter of Syed Lab & Radiology, the following discount facilities can be availed for the staff members and their family members:
 - 25% discount on all types of tests including hormones & PCR.
 - 25% discount on radiology services (Report charges are excluded).
 - 07% discount on all types of medicine from Syed Pharmacy.
2. Upon receiving letter of District Police Office Bahawalpur, Syed Lab & Radiology will allow upto 40% special discount for families of Martyrs & Ghazi Police Officers/Officials.
