- ➤ All radiology investigations, including but not limited to X-rays, ultrasound, CT scans,
- and MRI, shall be offered at a 40% discount on standard rates.
- ➤ For families of martyred police officers (Shuhada), a reasonable number of essential tests shall be provided free of cost, as determined and approved mutually on a case- by-case basis.
- ➤ Home sampling services will be provided free of cost for all referred individuals.
