



**Memorandum of Understanding
Between
Punjab Police-Government of the Punjab
&
Rizzle Pharmacy, Bahawalpur**

1. Purpose

The purpose of this Memorandum of Understanding (MOU) is to establish a cooperative relationship between the Bahawalpur Police Department and Rizzle Pharmacy. This collaboration aims to provide police personnel with discounted access to medications and related products, and to support community health initiatives.

2. Objectives

- **Service Provision:** Rizzle Pharmacy agrees to provide the following products and services at discounted rates to police personnel. (Serving, Retired, Shuhada families and families of those who died during service).
 - General medicine at a 12% discount
 - Herbal medicine or products at a 12% discount
 - Pampers at a 10% discount
 - Milk range at a 2% discount
 - Special provisions for diabetic patients during events
- **Coordination and Communication:** Both parties will establish and maintain clear communication channels to facilitate effective coordination, address any issues promptly, and ensure timely responses to requests or emergencies.

3. Responsibilities

- **Bahawalpur Police Department:**
 - Designate a primary point of contact for all communications with Rizzle Pharmacy.
 - Ensure that all personnel are informed of the benefits available under this MOU.
 - Provide Rizzle Pharmacy with necessary documentation or identification to verify eligibility for discounts.
- **Rizzle Pharmacy:**
 - Offer the agreed discounts to authorized police personnel upon presentation of appropriate identification/Police Service Card/ Rizzle Police Card.

- Maintain accurate records of transactions and provide periodic reports to the Police Department if requested.
- Ensure the confidentiality and security of all personal information received from the Police Department.

4. Confidentiality

Both parties agree to protect the confidentiality of sensitive information exchanged under this MOU. This includes, but is not limited to, personal information of police personnel and any proprietary business information. Both parties will comply with all relevant privacy laws and regulations.

5. Duration.

This MoU will be effective from 25.02.2025 for one year and will remain in effect until further modification or renewal by both parties within a year.

6. Review and Amendments

- This MOU will be reviewed annually by both parties. Any amendments or modifications must be made in writing and signed by authorized representatives of both parties.

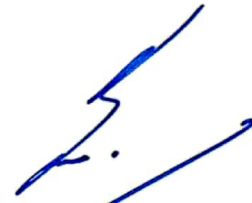
