


### Memorandum of Understanding Between

### SITC Hospital Bahawalpur

(85-A, Opposite Noor Mahal, Bahawalpur.)

#### 1. Preamble

This Memorandum of Understanding (MoU) is entered into on this 24day of March 2025, by and between:

- District Police Bahawalpur, an integral unit of the Punjab Police, responsible 1. for law enforcement, crime prevention, emergency response, and public safety services in Bahawalpur.
- SITC Hospital, Bahawalpur, a renowned healthcare institution providing 2. quality medical services to the people of Bahawalpur.

### 2. Objective

The purpose of this MoU is to facilitate the welfare of District Police Bahawalpur employees by offering special healthcare benefits at SITC Hospital, Bahawalpur, in recognition of their dedicated services.

### 3. Terms and Conditions

In furtherance of the objective, both parties agree to the following terms and conditions:

### 3.1 Healthcare Discounts and Priority Services

- Upon presenting a valid District Police Bahawalpur Service Card, police personnel will receive a 50% discount on consultation fees at SITC Hospital, Bahawalpur.
- All District Police Bahawalpur employees and their family members will be eligible for this discount.
- District Police Bahawalpur employees will be given priority treatment at the hospital.

### 3.2 Discounts on Procedures and Surgeries

- SITC Hospital will provide a 25% discount on all procedures and surgeries, applicable to the surgeon's fee and profit margin of services that are not outsourced.
- The hospital administration will share an updated list of revised service charges with the District Police Bahawalpur annually.
